Update: Digital Asset Symposium (DAS)

The first DAS webinar will be held July 23. The webinar will be offered at no charge, underwritten by Iron Mountain Entertainment Services, Seagate by Tape Ark, Image Protection Services, and LAC Group.

DAS will be a two day virtual event – September 16/17. Sessions will be prerecorded with a live Q&A component. Tech talks, sponsor provided technical talks, will once again be incorporated into the schedule and the Board will consider a similar format for the Conference.

Update: Development

AMIA 2020

The Call for Proposals will be reopened. This will allow those who knew they could not participate in person to submit proposals for the virtual conference.

The Board discussed scheduling for the conference, outlining options to have workshops in the weeks leading to the conference; moving the conference to a Tuesday to Friday timeframe; timing to accommodate multiple time zones.

Networking will be one of the challenges in a virtual conference – ideas include watch parties, roundtables, karaoke, small trainings, and demos. Similarly, more discussion is needed to plan for keynote(s), posters, and vendors.

The annual business meeting will take place during the conference week via Zoom so that the Board changeover can proceed on time.
