The 2017/2018 Annual Report will be sent to members in December, but here is a look a few of the year's highlights ..

After the new website launched in January, the International Outreach Committee worked with the developer to translate the full site into Spanish for the first time, and is looking at how to add additional resources.

The Education Committee has worked to provide students more resources, including a Conference 101 Guide, a Virtual Connect for anyone attending their first conference, a student basecamp site, a Student Orientation webinar, and student mixer at the conference.

Recognizing Advocacy is integral to AMIA's mission, the Board created an Advocacy Committee of the Board. The Committee works to identify and explore ways that AMIA can be responsive to and advocate to support the work of archival professionals, institutions, and the collections they represent.

The Continuing Education Advisory Task Force is working to develop strategic goals for AMIA's continuing education. While this work continues, the Board and committees continue to work on ways to provide opportunities for online learning and skill sharing through webinars like Facilitating Discussions, or Virtual Connects that bring experts and audiences together online

As the conference grows, we continue to look for ways to become more welcoming and offer more opportunities for discussion and learning. This year the Conference Committee worked with the Board, the Education Committee, and the International Outreach Committee to offer new programs like the Conference Navigators, Small Group/Roundtable discussions, committee and peer-to-peer activities, webinars on conferencing for newcomers, and facilitated discussions. In creating the pAVilion, we wanted to offer a place to bring many of these together in one hub of activity. Please tell us what you think and what we can do better!

Outreach and Collaboration. At a panel presented at Getting Real, a bi-annual conference from the International Documentary Association, AMIA members spoke to an audience of filmmakers on the need for preservation planning. One outcome – a resource page on the AMIA website.

AMIA representatives at the National Film Preservation Board serve on the Board's Diversity, Equity, and Inclusion Task Force as well as the Communication Task Force.

AMIA's support of the Community Archiving Workshop at Association of Tribal Archives, Libraries, and Museums led to a plenary discussion at this week's conference.

This summer AMIA participated in a discussion with colleagues at SAA, ALA and other organizations to find ways to better collaborate on field-wide concerns, including diversity, inclusion, and equity initiatives at each organization.

AMIA continues to collaborate with its CCAAA partners. In 2019, we will co-host the Joint Technical Symposium in Amsterdam with our colleagues from IASA, FIAF, and FIAT/IFTA.
